**MEMORANDUM**

**To:** Mainstream Medicaid Managed Care Plans (MMCPs), Health and Recovery Plans (HARPs) and HIV Special Needs Plans (HIV SNP)  
**From:** New York State Office of Mental Health (OMH)  
**Date:** December 13, 2022  
**Subject:** Youth Assertive Community Treatment (ACT) Teams

The purpose of this memo is to notify Mainstream Medicaid Managed Care Plans, Health and Recovery Plans and HIV Special Needs Plans (MMCPs) of additional providers that have been identified to operate a Youth ACT Team. The providers are in the process of obtaining OMH licensure and once licensed will be included in the Exhibit 4 Contracting Status Report Template.

Below is a comprehensive list of Youth ACT providers in the process of obtaining licensure to date with the most recent providers identified by an asterisk (\*). Providers identified with an asterisk are in addition to those referenced in the memos issued on [May 28, 2021](#), [June 23, 2021](#), [December 7, 2021](#), [May 25, 2022](#) and email correspondence on March 30, 2022. It is anticipated the new Youth ACT teams will begin accepting referrals March 1, 2023. MMCPs are required to have an adequate network of ACT providers to ensure timely access to services and are encouraged to offer contracts to new ACT teams in their service areas. OMH will include provider level information for the new teams in Exhibit 4 and PNDS to be used for contracting purposes as outlined in the above referenced memos.
