Dear Housing Provider,

The Office of Mental Health (OMH) is providing guidance for the implementation of the 2024-25 Budget pursuant to State Plan Amendment (SPA) 20-0005, which permits the State to pursue Medicaid reimbursement for Rehabilitative and Tenancy Support Services provided in OMH funded Supportive Housing (SH) and Community Residence Single Room Occupancy (CR-SRO) programs. OMH has a longstanding commitment to housing with funding for rehabilitative services and tenancy supports to help individuals live successfully in the community. The approved SPA 20-0005 will enable the State to preserve and support needed tenancy supports and services.

The third enrollment opportunity to participate in the SH SPA is now available. Providers operating eligible Supportive Housing and CR-SRO programs will be able to enroll programs that are not already participating. Eligible programs enrolled to participate will receive a SH SPA increase (\$1,200 for Downstate programs and \$600 for Upstate programs) to further support the provision and recording of these services.

Providers will be required to submit a completed attestation (enclosed) to OMH by December 31, 2024 to participate and receive a stipend increase that will take effect January 1, 2025. This form can also be located at the following link:

**OMH Frequently Asked Questions (FAQ) on Implementation of Rehabilitation and Tenancy Supports for Supportive Housing**: OMH complied a full list of FAQs on a wide range of questions being raised by Supportive Housing providers relating to the implementation of SPA #20-0005 including but not limited to: general background, service definitions, funding mechanics, participation rules, eligibility determinations, and monthly reporting requirements and service record requirements. **Supportive Housing Guidelines (Issued September 30, 2022):** OMH updated the Supportive Housing Guidelines to including all the details of SPA 20-0005 implementation including service definitions including psychosocial rehabilitation, counseling and other services to help beneficiaries maintain housing in the community, as well as CAIRS monthly reporting requirements. **State Plan Amendment (SPA) 20-0005 Rehabilitative Housing Tenancy Supports:** A copy of the approved New York State Plan pages with descriptions of covered rehabilitative services, staff qualifications and reimbursement. In addition, a copy of the 1915 c waiver for selective contracting. The waiver limits the State Plan covered benefit to individuals in supportive housing programs funded by the State and authorizes OMH to submit billing for services provided by subcontractors.

OMH conducted training webinars on December 19, 2022 and October 3, 2024 to provide an overview of this initiative, review the participation requirements, and respond to questions providers had as they navigated this decision.
