<p>OASAS is amending various regulations to provide updates to regulatory language in accordance with person-centered, trauma informed care, to restrict the ability to conduct cavity searches in OASAS certified programs and to address the provision of medication for addiction treatment in all OASAS certified settings. OASAS is adding the Adolescent Program Endorsement and Ancillary Withdrawal designation to Part 830.</p>
