Transforming New York's Mental Health System

Overview

New York is leading the way in making mental health care more accessible for everyone. Funded through a historic \$1 billion investment, the state is helping New Yorkers of all ages get the mental health care they need when and where they need it. As part of an overall effort to improve wellness, the state is strengthening key areas of its system of care.

Funding awards are organized in the following priority areas:

1. **Prevention & Youth Services:** Helping youth, young adults, and families address mental health issues earlier in life they may achieve the best possible future. This priority area includes specific awards for programs such as Health Home Plus, Suicide Prevention, Healthy Steps Program, etc.
2. **Access to Care:** Expanding mental health services and supporting housing to help New Yorkers live meaningful and productive lives. This priority area includes specific awards for programs such as Apartment Treatment Housing, Certified Community Behavioral Health Clinics (CCBHCs), CTI, Transitional Residence, etc.
3. **Specialized Services:** Bringing stability to individuals often disconnected from traditional mental health supports. This priority area includes specific awards for programs such as Assertive Community Treatment Teams (ACT), Intensive and Sustained Engagement Teams, Safe Options Supports (SOS), etc.
