### **Changes to the Survey Form**

**Question 5:** Question changed to Sex on Birth Certificate and added "Intersex" as an option

**Question 6:** Question changed to Gender and now has "Cisgender", "Transgender Woman", "Transgender Man", "Non-Binary", "Gender Non-conforming", "Client didn't answer", "Unknown" as possible responses

**Question 10:** Added Qualified Residential Treatment Program (QRTP) to Institutional setting for youth response. Added clarification on Homeless definition. Added "Individualized Residential Alternative (IRA)" to "Other" response

**Question 13:** Added clarification on Homeless definition

**Question 17a:** Question changed to "What best describes the client's religious and spiritual preferences?"

**Question 19:** Changed response to "Employed (Competitive or Self-employed)". Added "underage of employment/ below working age" to Not in Labor Force response.

**Question 21:** Question changed question to "Has client attended school (in person or virtual), home tutoring, or received education instruction at any time in the past three months?"

Question 26e: Question changed to "Coronary Vascular Disease"

**Question 26f:** Question changed to "Cerebrovascular Disease"

Question 26q: Question changed question to "Long COVID-19"

Question 45: Dates of Client Service updated for 2023 Survey Week

Question 9i: If 9c Asian is selected, select one of the following

Question 24g: Tobacco Use Disorder

Question 24n: Major Neurocognitive Disorder (dementia) of any subtype

Question 25d: Has the client received a COVID-19 booster in the last 12 months?

**Question 29:** In the last 12 months, has the program assessed the client's stage of change?

**Question 31a:** In the last 12 months, did client receive any medications for Alcohol Use Disorder (e.g., naltrexone, acamprosate, disulfiram) from this program?

**Question 31b:** In the last 12 months, did the client receive any psychotherapy or counseling for alcohol use disorder from this program?

**Question 32a:** In the last 12 months, did client receive any medications for opioid use disorder (e.g., long-acting naltrexone, buprenorphine) from this program?

**Question 32b:** In the last 12 months, did the client receive any counseling or psychotherapy for opioid use disorder from this program?

**Question 33:** In the last 12 months, did client receive any treatment for any other Addiction Disorder from this program?

**Question 34:** In the last 12 months, was the client screened for Hepatitis C?

**Question 35:** In the past 12 months, did the client have any thoughts of killing themself?

**Question 36:** In the past 12 months, did the client have a suicide attempt?
