The Office of Mental Health has removed the restriction only allowing agencies to applying for ONE (1) of the Intensive Community-Based Services for Children/Youth grant opportunities. As such, agencies who are eligible under multiple program categories can now apply for more than one grant under this opportunity. Eligible agencies must submit a separate application for each grant for which they are applying. As a result of this change, the date for applications has been extended to March 1, 2022

NOVEMBER 10, 2021 UPDATE

The Office of Mental Health has extended the deadline for applications for the Intensive Community-Based Services for Children/Youth grant opportunity. Applications are now due by December 31, 2021.

OCTOBER 18, 2021 UPDATE

The Office of Mental Health has removed the exclusion of Certified Community Behavioral Health Clinics (CCBHC) in the federal demonstration from applying for the Intensive Community-Based Services for Children/Youth grant opportunity. CCBHCs in the federal demonstration are now eligible to apply and receive grant funding under this opportunity. As a result of this change, the date for applications has been extended to November 30, 2021.

The New York State Office of Mental Health (OMH) is providing one-time funding up to \$50,000 to OMH providers to expand timely in-person and telehealth access to intensive community-based services. Specifically, these resources are intended to support children and youth returning to school for 2021-2022 in the wake of the coronavirus pandemic, in alignment with the design and intent of the Coronavirus Response and Relief Supplement Appropriations Act. Specifically, the Mental Health Block Grant is “designed to provide comprehensive community mental health services, including services that address the needs of children, particularly in regard to school re-entry and related crises for children and adolescents.”

Timeframe:

- Date that applications must be received by: November 1, 2021
- Date that expenditure is available against funds: September 15, 2021
- Providers must expend funds by December 31, 2022
