### PSYCKES-Medicaid Release Notes - Release 8.4.0

### 1. Separation of My QI Report's Indicator Set Tabs

In My QI Report, the Quality Improvement and Performance Tracking indicator sets will now be separated into two tabs to help users more easily identify the different indicator set's 'as of' dates. The Quality Improvement measures are run on a monthly basis, whereas the Performance Tracking measures are run with an intentional lag of 6 or more months to allow for complete data to display. The DOH Performance Tracking measures are as of 12/1/2024 as DOH have not yet updated data.

## 2. Update to Health Home Plus (HH+) Eligibility Criteria

The criteria for Health Home Plus (HH+) eligibility criteria in PSYCKES has been updated to better align with the Health Home Plus definition. The criteria will now include individuals who have had homelessness in the past 6 months and a Department of Health (DOH) defined Serious Mental Illness (SMI) diagnosis in the past year. This criterion has been added to the Recipient Search High Need Population dropdown as its own filter selection, and to the PSYCKES HH+ Eligibility algorithm. This new criterion will also be applied to the Health Home Plus eligible quality indicators located within the "Health Home Care Management – Adult" and "Vital Signs Dashboard – Adult" indicator sets. For reference, the homelessness data is coming from both Medicaid billing and the NYC Department of Homeless Services (DHS) database.

# 3. New Service Settings: Youth ACT, Crisis Stabilization Center, and Comprehensive Outpatient Program (COP)

New service settings have been added to the Recipient Search "Service Setting" filter boxes, the client-level Clinical Summary, My QI Report, and Statewide Reports. These new settings include Youth ACT, Crisis Stabilization Centers, and Comprehensive Outpatient Programs (COP):

#### 4. iOS Mobile App Release 8.4 Enhancements

To maintain parity between the iOS and web platforms, the new service settings (ACT – Youth, Crisis Stabilization Center, and Comprehensive Outpatient Program) will be available within the iOS Clinical Summary, when applicable to the client.

- 2) **PSYCKES App update** To update to the most recent version of the PSYCKES mobile app, please navigate to the App Store > Search for "PSYCKES" > Select "Update" button
