



Introduction

Pursuant to Mental Hygiene Law §7.47(c), the New York State Office of Mental Health (OMH) is required to report annually on expenditures from the Mental Illness Anti-Stigma Fund. This fund, signed into law in November 2015 and launched in 2016, creates a voluntary tax check-off on New York State income tax forms. The program provides a simple and direct way for New Yorkers to support statewide efforts to eliminate the stigma associated with mental health concerns and conditions.

OMH uses contributions to the fund to award grants to organizations that conduct educational campaigns and stigma-reduction initiatives. Eligible activities include, but are not limited to, targeted advertising and messaging; educational material development; trainings; community events featuring individuals with lived experience; speaking engagements; and multimedia productions.

OMH uses the following statement for all projects supported by program funding: "This project is funded by the New York State Office of Mental Health and the New York State tax check-off program to reduce mental health stigma."

The OMH Public Information Office also developed a <u>public-facing informational video</u> to raise awareness of the check-off option and highlight its role in reducing mental health-related stigma.
