

Profile of Children in NYS Medicaid with Behavioral Health Needs Tableau Report Definitions

Demographics

Aid Category: Hierarchical aid category for children who ever had that aid category for a given year. Aid categories include: Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF) and Other. The Other category includes children receiving foster care, however, this data does not show all children in foster care.

Plan Type: The child's Medicaid plan type during the last month of enrollment in the given year.

Region: The child's region of residence during the last month of Medicaid enrollment in any given year. Regions include New York City, Western NY, Hudson River, Central NY, Long Island, and Office of Mental Health/Office for People with Developmental Disabilities (OMH/OPWDD).

Age Group: The child's age during the last month of Medicaid enrollment in the given year.

Gender: The child's gender during the last month of Medicaid enrollment in the given year.

Race & Ethnicity: The child's race and ethnicity during the last month of Medicaid enrollment in the given year.

Behavioral Health Diagnoses

Any Behavioral Health (BH) Diagnosis: Includes any of the Mental Health/Substance Use Disorder (MH/SUD) diagnoses listed below in the given year.

Substance Use Disorders: Mental and behavioral disorders due to psychoactive substance use. Primary, secondary and all position diagnoses 'F1XXX' in the given year.

Psychosis: Schizophrenia, schizotypal, delusional, and other non-mood psychotic disorders. Primary, secondary and all position diagnoses 'F2XXX' in the given year.

Mood Disorders: Mood affective disorders. Primary, secondary and all position diagnoses 'F3XXX' in the given year.

Affective Psychosis: Unspecified mood affective disorder. Primary, secondary and all position diagnoses 'F39XX' in the given year.

Anxiety Disorders: Anxiety, dissociative, stress-related, somatoform and other nonpsychotic mental disorders. Primary, secondary and all position diagnoses 'F4XXX' in the given year.



Behavioral with Physiological Disturbance: Behavioral syndromes associated with physiological disturbances and physical factors. Primary, secondary and all position diagnoses 'F5XXX' in the given year.

Personality Disorders: Disorders of adult personality and behavior. Primary, secondary and all position diagnoses 'F6XXX' in the given year.

Disruptive Behavioral Disorders (e.g. ADHD): Behavioral and emotional disorders with onset usually occurring in childhood and adolescence. Primary, secondary and all position diagnoses 'F90XX' to 'F98XX' in the given year.

Services and Costs

Physical Health Outpatient (PH OP): OPWDD Clinic, OPWDD Day Treatment, Developmental Disability (DD) Non-Licensed Clinic, NON-BH Clinic, NON-BH Practitioners, OPWDD Waiver, Department of Health (DOH) Waiver, Office of Children and Family Services (OCFS) Waiver, OPWDD Coordination or DOH Case Management in the given year.

PH OP Cost: Total cost of all listed services in this category spent in the calendar year in the given year.

Physical Health Inpatient/Emergency Room (PH IP/ER): Non-BH inpatient; Non-BH Emergency Room (ER) in the given year.

PH IP/ER Cost: Total cost of Total cost of all listed services in this category spent in the calendar year in the given year.

Behavioral Health Outpatient (BH OP) Specialty: OMH/Office of Addiction Services and Supports (OASAS) Certified Community Behavioral Health Clinic (CCBHC), OMH Licensed Clinic, OMH Assertive Community Treatment, OMH Continuing Day Treatment, OMH Children's Day Treatment, OMH Family Based Treatment, OMH Intensive Outpatient Program, OMH Partial Hospitalization, OMH Prepaid Mental Health Plan, OMH Teaching Family Home, OMH Targeted Case Management, OMH Residential Treatment Facility, OMH Community Residence, OMH Personalized Recovery Oriented Services, OMH Intensive Psychiatric Rehabilitation Program, OMH Child Waiver, Home and Community-based Services (HCBS), OASAS Opioid, OASAS Chemical Dependence, OASAS Clinic, OASAS Medically Supervised Withdrawal OP, OASAS OP Rehabilitation, OASAS Residential Redesign Part 820, OASAS Residential Rehabilitation for Youth in the given year.

BH OP Specialty Cost: Total cost of all listed services in this category spent in the calendar vear in the given year.



BH OP Non-licensed: OMH Collaborative Care, OMH Integrated Care, MH Non-Licensed Clinic (diagnosis or procedure based), BH Outpatient Practitioner, SUD Non-Licensed Clinic, SUD Integrated Care in the given year (2016, 2017, or 2018).

BH OP Non-licensed Cost: Total cost of all listed services in this category spent in the calendar year in the given year.

Behavioral Health Inpatient/Emergency Room (BH IP/ER): MH Inpatient, MH ER, SUD Inpatient, SUD ER in the given year.

BH IP/ER Cost: Total cost of all listed services in this category spent in the calendar year in the given year.

Health Home (HH): Health Home Assessment, Health Home Enrolled, Health Home Outreach services in the given year.

HH Cost: Total cost of all listed services in this category spent in the calendar year in the given year.

Medication (BH RX): Prescribed any BH/MH medication in the given year.

BH RX Cost: Total cost of BH/MH medication spent in the given year.

Average Annual Cost: Average annual costs include all healthcare-related claims, encounters, and miscellaneous costs for services and pharmacy in the given year. This excludes premiums.

3M™ Clinical Risk Groupings (CRG)

Children's clinical risk was categorized using 3M[™] Clinical Risk Groups (CRG) attributes included in OMH Medicaid. CRG levels are based on a prior year of Medicaid claims including inpatient and outpatient diagnoses, procedures and pharmacy claims. A single CRG level (from 9 = most severe to 1 = least severe) was assigned to each child.

Chronic Physical Health Conditions

Diabetes: Chronic physical condition indicator of diabetes in the given year. CCS category: 3.3, 3.2

Cardiovascular Disorder: Chronic physical condition indicator of dyslipidemia in the given year. CCS category: 3.6, or chronic physical condition indicator of heart disease in the given year. CCS category: 7.2, or chronic physical condition indicator of hypertension in the given year. CCS category: 7.1, or chronic physical condition indicator of cerebral infarction in the given year. ICD10: I63xx

Obesity: Chronic physical condition indicator of obesity in the given year. ICD10: E66xx



Respiratory Disease: Chronic physical condition indicator of respiratory disease in the given year. ICD10: J40- J45, J47 (includes COPD, bronchiectasis and asthma). Epilepsy/Seizures: Chronic physical condition indicator of epilepsy or convulsions in the given year. ICD10: G40, R56

Any Chronic Physical Health Condition: Includes all the chronic physical health conditions listed above in the given year.

Medications

Total MH/SUD Medication: Includes all the medications listed below in the given year.

Antidepressant: Had an Antidepressant class of medications in the given year.

Antipsychotic Clozapine: Had Clozapine in the given year.

Antipsychotic: Had an antipsychotic class of medications other than Clozapine in the given year.

Anxiolytic: Had an anxiolytic class of meds in the given year.

Mood Stabilizer: Had a Mood Stabilizer class of drug in the given year.

Stimulant: Had a stimulant class of drug in the given year.

Any SUD Medication: Had a SUD drug in the given year. This includes Anti-Craving and Smoking Cessation medications.
